I am sad to report that very few surveys were submitted. Thus, no statistically valid results can be presented.

Since I also keep the Roster, I have noticed a decline in the number of members of the Crew. Losses due to deaths combined with fewer nominations are factors contributing to this decline. Many current logs are returned and I fear many may be deceased that we are unaware of. Even with those US Jaycee officers who become automatic members (Mates) at the end of each year we will have a net loss of Mates. While keeping the roster I have observed that many past State Presidents have yet to be nominated as Mates of the CREW. I would ask that you consider nominating your past State Presidents.
