15th Judicial Circuit

Taylor Chosen as Judge

Gov. Mills E. Godwin Jr. today made the same choice as the Hanover Bar Association and named Richard H.C. Taylor to succeed Edward P. Simpkins Jr. as judge of the 15th Judicial Circuit.

Godwin announced the appointment of Taylor, chairman of the Hanover County Democratic Committee, to fill the Hanover judgeship from which Judge Simpkins will retire Sept. 1. Godwin's appointment is subject to confirmation by the 1978 General Assembly.

Taylor was endorsed Friday by the Hanover Bar Association, which earlier had

endorsed Andrew J. Ellis Jr. Ellis later withdrew his name from consideration for the judgeship.

HANOVER NATIVE

Taylor, 47, a native of Hanover County, is a partner in the Richmond law firm of McCaul, Grigsby and Pearsall. He is a member of the 15th Judicial Circuit and Richmond bar associations.

He has been commissioner in chancery for the Hanover Circuit Court, assistant commissioner of accounts for Hanover County, and is escheator for the counties of Hanover, Caroline and New Kent.

Taylor also is a member of the Governor's Committee on Employment of the Handicapped, former president of the Virginia Heart Association, vice president of the American Heart Association and former president of the American Cancer Society's Hanover County unit.

He also has been state president of the Jaycees and the organization's national director.

In addition, he is a member of the board of directors of United Virginia Bank in Hanover County and was coordinator of Virginians, for the Bond Issue in 1968.

Taylor has been an active member of St. Paul's Episcopal Church in Hanover.

The 15th Judicial Circuit is composed of the city of Fredericksburg and the counties of Caroline, Essex, Hanover, King George, Lancaster, Northumberland, Richmond, Spotsylvania, Stafford and Westmoreland.
