The following speakers are scheduled for Saturday, April 27 --

Increasing Jobs and Competitiveness Through Small Hi-Tech Firms

Mate **Roland Tibbetts**, (655 Mine Ridge Rd., Great Falls, VA 22066) former Executive Vice-President of USJCC will lead off the Saturday program of the reunion of The Crew with an exposition of the most successful national program to advance small business. The Small Business Innovation Research Program helps inventors across the chasm from scientifically sound theory to sprouting practical technology. The grant program serves only the earliest phase of innovation that venture capitalists shun. Then creators are pushed into the private financial market.

While America's large companies have lost more than 3 million employees in recent years, small businesses have added more than 14 million. The very essence of small business is detection and exploitation of ways to do useful things better. Very few small businesses can survive against stronger competitors without better ideas. The United States would have a dying economy without a stream of new enterprises based on superior products and services.

Tibbetts, who served as Vice President of Hazelton Laboratories, a biomedical research firm, and President of the Fairfax Chamber of Commerce, conceived and promoted the Small Business Innovation Research Program and later directed it from a post in the National Science Foundation.

Mate Tibbetts could have a key to your own hopes to become a present-day Henry Ford, George Eastman, Charles Goodyear or Bill Gates. Be there at 9 A M, Saturday, April 27.

Future Publication of *The Log*

The US Jaycees Foundation and US Junior Chamber of Commerce have generously borne the costs of collecting information, maintaining mailing lists, writing, printing and mailing *The Log* since the days of Johnnie Armbruster. This continues now; but it has been proposed that The Crew assume these burdens, to free up the money to provide other services and grants to Jaycee chapters. This proposal was mentioned in the last two issues of *The Log*; since then, many Mates have weighed in with their opinions and alternatives.

After reviewing the various options and considering the views expressed by all Mates who chose to participate in the discussion, it was decided that, **after this issue**, *The Log* would be produced by The Crew at the expense of those who want to receive *The Log*. The cost per Crew member would be small, calculations indicate. An **annual subscription donation of \$10** is expected to be sufficient. A subscription system also will serve to separate interested members of The Crew from persons with no continuing desire to be included, thereby saving waste. There are currently over 1,300 Mates on the rolls; however, only 20-30% contribute news and materials, nominate new members, or participate in Crew reunions. We don't even have current addresses for over 100 Mates.

As many of you know, the members of the US Junior Chamber of Commerce Executive Committee automatically become members of The Crew upon their election. Plans are to provide them copies of *The Log* during their term of office. Other nominees for membership (after the 1996 Crew Reunion) should be accompanied by a check from the nominator for the nominee's subscription donation for the first year. After that time, the individual Mate should pay their subscription donation themselves.
